



## REFERRAL AND AFFILIATE PROGRAMME FOR PROPERTY PROFESSIONALS

### What's the referral and affiliate programme about?

The Referral and Affiliate Programme is an opportunity for property professionals to earn money whilst recommending Viewber services.

#### The Referral Programme

- Only valid when referring estate agents, property manager, auctioneers and property developers to Viewber
- Earn a one off referral fee after the minimum amount of completed appointments
- No limit to the number of referrals
- Once 15 appointments have been completed, you'll need to provide an invoice in order to claim the referral fee

#### Affiliate Programme

- Earn a % of the gross fee per completed appointments
- Only valid for estate agents, property managers, auctioneers, property developers to Viewber
- Payment made within 60 days of completed appointments
- Only available to applicants who hold a website or social media presence and using an affiliate link to refer clients

### How much can you earn?

If you refer a new client to Viewber who subsequently books and completes appointments, you will be eligible to earn fees based on the structure below.

	Referral Fee
Referral fee per client once the client has completed 15 appointments	£100
Affiliate fee per completed booking	5%

## Terms & Conditions

From this point, “You” and “Your” refers to the referring business or individual.

### Payments

Payments will be made to you on a monthly basis via BACS transfer, subject to a minimum total of £25 earned. Affiliates will earn 5% of the gross fee for each completed booking made by any new client they introduce to the Viewber system via their uniquely assigned weblink. Clients must sign up using the affiliate’s unique URL/weblink to qualify.

### Viewber Exclusions

To be a Viewber referrer or Affiliate, you must continue to be approved as such by Viewber, and to be able to participate on the Viewber platform. Viewber reserves the right to remove your approval, or exclude you from the Viewber platform, at any time.

### Honesty and Integrity

You should be honest about our services and provide a clear, accurate description of what Viewber can provide. You must not provide false or misleading information when communicating to potential clients.

## Further Terms & Conditions

### Tracking Links

If you are approved as an Affiliate, you will be supplied with a tracking URL that is unique to you. It must be used by a new client when that new client completes a registration with Viewber for you to be eligible for any referral payments from that new client. You will be informed if you are assigned as an Affiliate to a new Viewber client.

### Existing or non-approved clients

Even if a business tries to sign up for Viewber services through your website, you may not be assigned as their Affiliate because that business may already be a client, in our pipeline, or may not for numerous reasons be approved as a client.

You will be notified of any such changes. If the programme is suspended or removed, you will not receive referral fees in respect of future bookings.

Once you become an approved Referral or Affiliate member, you may use our the Viewber logo, Affiliates can use the status badge and Viewber’s brand name and slogan on your website. You will be provided with these materials if you become an approved Affiliate.
